INVESTMENT OBJECTIVE

The Sub-Fund's investment objective is to seek maximising total return, consistent with preservation of capital and prudent investment management.

INVESTMENT STRATEGY

The Sub-Fund's investment objective is to seek maximising total return, consistent with preservation of capital and prudent investment management. The Sub-fund is a multi-asset portfolio, which will invest primarily in equities, government bonds, corporate bonds; exposures will be obtained via plain vanilla securities, as well as derivatives. The Sub-Fund aims to achieve its investment objective by taking exposure to a wide range of asset classes, including – but not limited to – equities, fixed income, foreign exchange as outlined below. The Sub-Fund shall not invest directly in commodities. The minimum amount of investments used to meet the environmental or social characteristics promoted by the Sub-Fund will be 51% of its net assets. In making investment decisions, the Investment Manager considers various quantitative and qualitative data relating to global economies and projected growth of various industrial sectors and asset classes. The Investment Manager uses a three-factor approach to evaluating asset classes and their risks in seeking to achieve the Sub-Fund's investment objective which consists of a) fundamental analysis relating to global economics and projected growth of various industrial sectors, b) valuation analysis, and c) assessment of market demand of and supply for asset classes. The Investment Manager evaluates these factors on an ongoing basis and uses a combination of direct investment, derivative exposure and marginally collective investment schemes to implement a resulting mix of asset classes within the Sub-Fund that reflects the Sub-Fund's investment objective. Similarly, although the Sub-Fund has the capability to use the types of investment outlined in this policy, it is possible that certain instrument types are not used all of the time. While analysis is performed daily, material shifts in investment exposures typically take place over medium to longer periods of time. For further details, please refer to the fund documents.

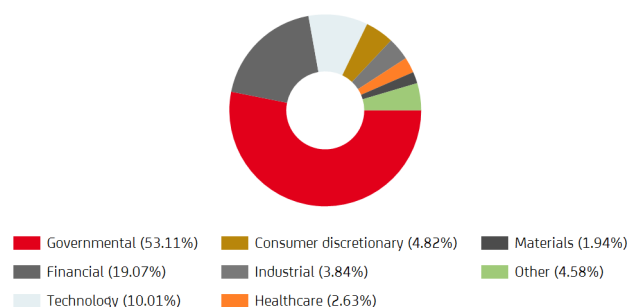

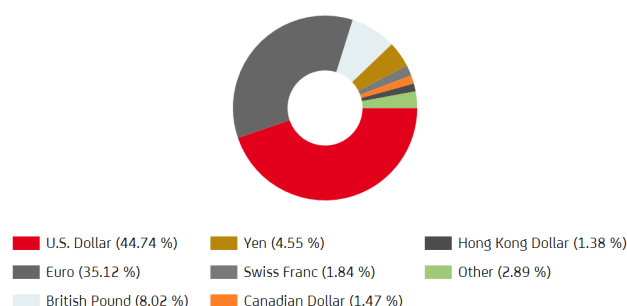
CURRENT COMPOSITION OF THE INVESTMENT PORTFOLIO

COMPOSITION OF THE INVESTMENT PORTFOLIO BY CURRENCY AS AT 31. July 2025

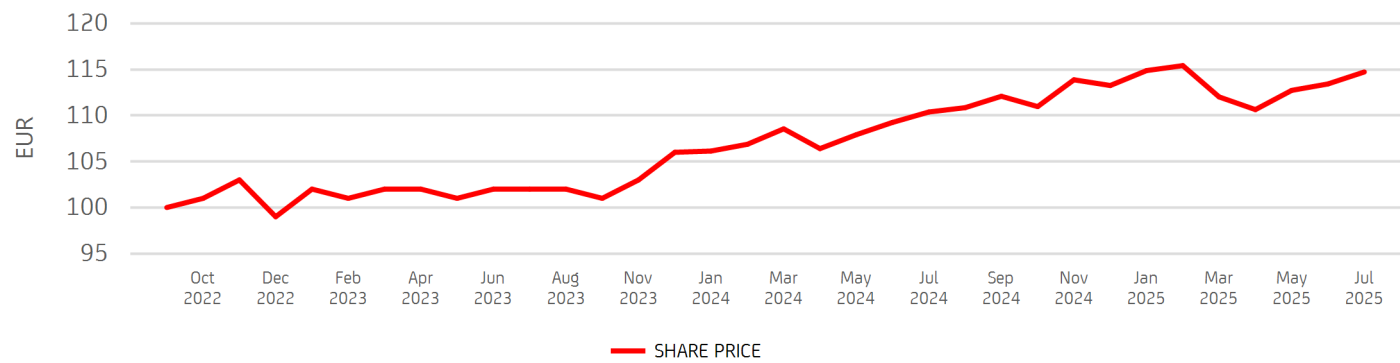

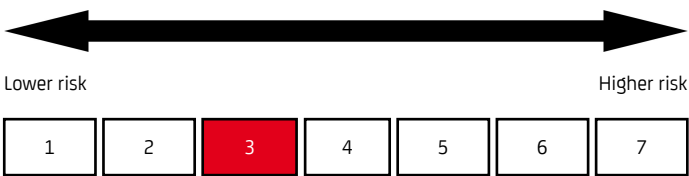
PERFORMANCE AND RISK MEASURES

RISK PROFILE



The historical data used to calculate the summary risk indicator may not be a reliable indicator of the future risk profile of the sub-fund. There is no guarantee that the risk category illustrated above will remain unchanged. A classification of the sub-fund in the lower category does not automatically mean that the investment is risk-free.

Risk classification of the sub-fund

The sub-fund’s strategy is to invest in different assets and derivative instruments. Due to the relatively high volatility of these investments, the fund is classified in risk category 3.

Other relevant risks

The credit rating of the issuers of the securities held by the sub-fund and its strategy may deteriorate over time. In the unlikely event that the issuer of a security is forced to declare itself insolvent, the value of the securities could fall significantly. This could lead to a reduction in the market price of the sub-fund that exceeds the general market fluctuations.

The sub-fund’s performance and the ability to buy, sell or redeem fund units may be hampered by economic developments and uncertainty caused by political events, changes in government policy, restrictions on capital flows and changes to the regulatory framework. Events such as natural disasters and political unrest can also have negative repercussions.

Under unfavourable market conditions, it may be difficult for the sub-fund to sell the securities held without incurring significant losses, or it may even be impossible to sell certain securities.

In this extreme case, it is possible that the sub-fund will experience payment difficulties, which could prevent investors from redeeming all their units immediately and without incurring significant losses. The sub-fund may perform derivative transactions and is therefore exposed to the risk of a counterparty failing to honour its contractual obligations. We reduce counterparty risk on derivative transactions by requiring our contractual counterparty to provide minimum collateral, as stipulated by the relevant regulatory requirements.

The sub-fund may incur losses due to malfunctions or inadequate internal procedures and systems, operational risks or external events. This includes the possibility of incurring losses due to a breach of applicable regulatory requirements, including losses caused by changes to the regulatory framework on existing transactions.

Derivatives are subject to specific risks arising from the “leverage effect”, which amplifies the change in the market price of a derivative compared with the actual change in the market price of its underlying. The risk of loss increases as the amount of leverage of the derivative increases.

Risks not sufficiently taken into account in the indicator include the following: equity risk, bond risk, commodity risk, risk arising from multi-asset investments, sustainability risk, risks related to investment funds, risk of debt securities, convertible bonds, contingent convertible (CoCo) bonds, hybrid bonds and bonds with a rating below investment grade or no rating, early repayment and extension risk, derivatives and counterparty risk, short position risk, high leverage risk, currency risk, geopolitical risk and emerging markets risk.
